

Board of Directors Meeting Minutes November 19, 2020

The Deaf Smith County Hospital District Board of Directors met in a regular monthly meeting on Thursday November 19, 2020 at 5:30 pm in the Education Room of Hereford Regional Medical Center.

1. Call to Order, Pledge and Invocation

Mike Schueler, Chairman, called the meeting to order at 5:35 p.m. Mr. Schueler led the Pledge of Allegiance and offered the Invocation.

2. Public Comment

No public comments.

3. Approval of Minutes

Mr. Woodard made a motion to approve the October 1, 2020 board minutes. Motion was seconded by Mr. Black. Motion carried.

4. Chairman's Report

Certificates of Election and Statement of Officers

6. Chief Financial Officers Report

Presentation of financial statements for September and October of 2020.

Mrs. Hunt presented the financial statements and statistical reports related to income, expenses, and budgeted operations for the periods ending September 20, 2020 and October 31, 2020. For the month of September, the district had a net loss of \$398,225 for the month, which was below budget and prior year. For the year, a net gain of \$2,348,402 for the year, which is above budget and higher than last year's bottom line, which showed a net gain of \$1,087,231. For the month of October, the district had a net of \$195,086 for the month, which was above budget and higher than prior year.

Physician Recruitment

COVID-19 Update

Mr. Barnhart and Mrs. Clements along with Dr. Rohm gave a brief update on COVID-19. We have tested 3,000 with 1500 positive. That is 10% of the population, that's 5 times the average. We continue with the COVID clinic and looking forward to the vaccine.

8. Medical Staff Report - Dr. Rohm

Dr. Rohm gave a brief report on COVID. He answered questions and concerns from the board regarding the virus, treatment, and vaccine.
