

Board of Directors Meeting Minutes October 24, 2024

The Deaf Smith County Hospital District Board of Directors met in a regular monthly meeting on Thursday October 24, 2024, at 5:30 pm in the Education Room of Hereford Regional Medical Center.

1. Call to Order, Pledge and Invocation

Kevin Bunch, Chairman, called the meeting to order at 5:30 p.m. Kevin led the Pledge of Allegiance and offered the Invocation.

4. Chief Financial Officer Report

Review and approve financial statements and statistical reports for period ending September 30, 2024.

Mr. Paul Gafford presented month end financial statements and statistical reports related to income, expenses, and budgeted operations for the period ending September 30, 2024. Our net income for September is \$75K. This month is a good outpatient revenue month and inpatient revenue is similar to last September. All departments counted their inventory this month and there is a (\$123K) reduction to supply expense. Total revenue is (\$98K) less than the budget and total operating expenses are (\$145K) less than budget. Cash and cash equivalents are \$23.6 million at year end which is a \$4.0 million increase over last year. The balance sheet is strong with 279.6 days cash on hand and a \$12.51 to \$1.00 current ratio. Mr. Chris Woodard made a motion to accept September 30, 2024, financials as presented. The motion was seconded by Mr. Tim Laws. Motion carried.
